RESOLUTION INTRODUCING LOCAL LAW NUMBER 1 OF 2017, A LOCAL LAW AMENDING THE EXEMPTION FOR COLD WAR VETERANS FROM REAL PROPERTY TAX PURSUANT TO REAL PROPERTY TAX LAW SECTION 458-B TOWN BOARD OF THE TOWN OF FORT EDWARD COUNTY OF WASHINGTON, STATE OF NEW YORK

WHEREAS, Section 458-b of the New York State Real Property Tax Law authorizes a partial exemption from real property taxes on qualifying residential real property owned by qualifying property owners whom are veterans; and

WHEREAS, currently the local law codified in Chapter 92 of the Code of the Town of Fort Edward, entitled "Taxation," Article V, entitled "Code War Veterans Exemption," §92-12 "Limitations; application for exemption" limits the exemption to a ten (10) year period; and

WHEREAS, on or about September 12, 2017, a law codified in Chapter 290 was passed with approval of the Governor that removes the ten (10) year limitation on the Cold War Veterans Exemption codified under Real Property Tax Law Section 428-b; and

WHEREAS, it is the desire of the Town Board to remove the ten (10) year limitation on the Cold War Veteran's Exemption as allowable under the new law for qualifying property owners of qualifying property within the Town of Fort Edward; and

WHEREAS, the Town Board of the Town of Fort Edward has previously authorized the Town Attorney to prepare a proposed local law that would provide the amendment to above-described exemption and the Town Board has reviewed the proposed local law that was prepared and is subject to this resolution.

NOW, THEREFORE, BE IT RESOLVED, THAT the Town Board of the Town of Fort Edward believes it is in the best interest of the Town to introduce for the purposes of adoption an introductory Local Law No. 1 of 2017 of the Town of Fort Edward which allows for The Cold War Veterans exemption to apply to qualifying owners of qualifying real property for as long as they remain qualifying owners, without regard to the ten (10) year limitation set forth in NYS Real Property Tax Law §458-b; and be it

FURTHER RESOLVED, that the Town Board determines that the adoption of the proposed Local Law is a Type II action under the New York State Environmental Quality Review Act (SEQRA); and be it

FURTHER RESOLVED, that the Town Board shall meet at the Town Hall of the Town of Fort Edward, Washington County, New York, on the 11th day of December, 2017 at 6:55 p.m., to hear all persons interested in the matter; and be it

FURTHER RESOLVED, that the Town Clerk is hereby authorized and directed to publish notice of said hearing in *The Post-Star*, the official Town newspaper and to post a copy of the same on the sign-board of the Town in the time and manner provided by law; and be it

FURTHER RESOLVED, that this resolution shall take effect immediately.
