WHEREAS, New York State has recently passed a law requiring the state to pay taxes on property it owns in the Washington County Towns of Fort Edward, Argyle and Kingsbury, including WMAs, starting on January 2019 and

WHEREAS, Friends of the IBA recognizes that the town of Fort Edward will lose tax revenue between the time of the State's purchase of the Pulver parcels and the enactment of the new tax law in January 2019.

NOW THEREFORE BE IT RESOLVED, that the Town Board authorizes the Supervisor to enter into an agreement with Friends of the IBA to accept a donation from Friends of IBA for one-thousand dollars (\$1000.00).
