Dennis Williams Boundary Line Adjustment

Chairman Belden: Since the last meeting we have received a new survey map. What is the lot coverage now? Is it under 30%?

The Board did the calculations and the lot coverage with the house, metal barn and shed is under 30%.

Chairman Belden: The well and the septic need to be sketched into the map.

The following memo was submitted by Town Engineer Jim Houston:

Dear Chairman Belden:

C.T. Male Associates Engineering, Surveying, Architecture, Landscape Architecture & Geology, D.P.C. (C. T. Male) has completed a review of the project documents that we received from the Town of Fort Edward for the Van Der Werken – Williams Boundary Line Adjustment. The package of information that we reviewed included the following documents:

- Boundary Line Adjustment Application, signature page dated 9-20-2018.
- Short Environmental Assessment Form, signature page (4 of 4) dated 11/14/18.
- Boundary Line Adjustment Survey "Lands now or formerly of Michael G. & Trisha A. Van Der Werken to be conveyed to Dennis J. & Ann Marie Williams"; dated October 23, 2017.

Based on our review of these project related documents, we offer the following comments for consideration by the Planning Board.

1. Regarding the "Boundary Line Adjustment Application" – Page 4: the acreages shown on this page conflict with the acreage information shown elsewhere in the document and on the survey plan.

Corrections to the lot, yard and height regulations

Proposed Lot Size – 1.42 Proposed Lot Width – 410' Proposed Lot Depth – 201.25'

- 2. Regarding the "Short EAF" Page 3 of 3, Question 20: this question was checked yes (consistent with the EAF Mapper) but the response is missing a description of the remediation activity.
- 3. Regarding the "Boundary Line Adjustment Survey" plan: the date on this plan is 23 October, 2017 and it should be updated to reflect the current submission.
- 4. Agricultural Data Statement this form was not included in the information that we reviewed but it should be updated and submitted for review. This form asks for a map that shows the project parcel and adjacent parcels within 500-feet and identify those parcels that contain agricultural uses named above. This information should be added to the survey map.

Chairman Belden: If you want to acquire more property from the Van Der Werkens you would have to do a minor subdivision which would be an additional \$300.00 because subdivisions include the town fees and Boundary Line Adjustments do not. Also by doing it that way you will not have any building restrictions like you would with a Boundary Line Adjustment.

Dennis Williams: We would like to do it all in one shot as opposed to doing a boundary line adjustment now and another one down the road.

Will LaPan: Once the lot is yours you can always combine it with your existing lot for assessment purposes.
