Town of Fort Edward, NY Dog Control DCO Report March 2025

I do not contract with WCPH to handle 10 day QT bite reports. I do keep track of all reported bites in the town.

3/ 4- I spoke to a woman on Summit who had a complaint about her neighbor walking her dog and the dog going to the bathroom too close to the sidewalk. She said the dog is small and is having a hard time due to the amount of snow and ice next to the sidewalk. I sent her a complaint form and have not received it back at this time.

k- I spoke to a woman on Notre Dame St about a dog she claimed she found in January and had me pick up. In February it was discovered that vet records indicate the dog came from her home. She admitted she had given false information to the WCS and to dog control. I spoke to the town supervisor and then I passed this information on to the town attorney. The kennel bill the town will receive will be \$400 and due to the fraud this woman committed against the town it seemed reasonable she should be held accountable for the sum. She agreed to pay it back to the town via the attorney's office.

3/24- I received a text from the woman stating she was injured and broken her wrists and this would keep her from being able to send the check by the end of the month. I passed the information on to the attorney via email.

3/10-I received a message from the WCS that a dog had been found late in the evening on Griffin Ave and they transported it to the kennel. The dog was claimed by the owner the next morning.

3/13-I received a call from a woman who found a small terrier on Hudson St. I posted the dog online and the owner was located while I was on my way to pick it up.

3/14- I received a call from a WCS deputy who received a report of a dog in a home where the owner had died. The adult children who inherited the house were to be caring for the dog but the neighbor did not feel the dog was getting proper care. I left her a message and she returned my call. I drove to the home in Drifting Ridge and left a card on the door with a request for the dog owner to contact me. They did not.

2/25 - the neighbor called me back. She had taken in the dogs, there were 2, and they killed a rabbit very late at night out in her yard. She contacted the sheriff who said they could not help her. She was looking to rehome the dog. I posted the dog online for her and began calling rescues to see if anyone could help her. She was leaving that day on a business trip and her mother decided to take the dogs in temporarily at her home in VT.

3/14- I received a call from a WCS deputy who responded to a call from a woman on McCrea St. that her neighbor's dog had gotten into her fenced yard and gone after her dog. The dog was not seriously injured. I spoke with the woman, she did not want to file DD, she just wanted a record of the incident in case it happened again. She stated the neighbors recently moved in when a family member who owned the house died and they have been difficult. She agreed to fill out a complaint form so I would have a written signed record of the complaint for future issues. After receiving her complaint form I sent out a warning letter to the dog's home informing them of the need for licenses and to keep the dogs on their owner property due to leash laws.

3/31- I received a message from the woman with the dogs. . She got the letter and called to say the dogs were licensed in Kingsbury and the dog who got loose was a one time incident and it would not happen again. I contacted the Kingsbury town clerk who had no record of them under her name. I called her back and informed her the licenses must be expired as the clerk was unable to find them. The woman then informed me the dogs belong to a friend and she is just watching them for a few months. I instructed her to have the friend call the clerk and get the licenses transferred to Fort Edward. She agreed to contact him and ask him to follow though.

3/18- I received a call from a WCS deputy to inform me he responded to a dog bite call on Broadway. 2 teenages were walking a dog and it bit a woman who was also out walking. I contacted the dog owner to find out if the dog was current on license and rabies. The dog has a rabies vaccine but needs a license. The dog is new to the family. One of his daughters was home and offered information on the incident. The woman walking (who lives in Queensbury) asked if she could pet the dog, the girls told her he may jump or grab at her as they had just finished playing with him and he was wound up. The woman reached for the dog anyway and the dog grabbed her hand. She then proceeded to call the girls names (one of them is handicapped and she targeted that upsetting the girl a great deal) and made threats. The girls immediately ran home and told their father what was going on. The WCS showed up at this point. The dog owner was shocked his dog did this as the dog has been well behaved for the past few months they have had him and he immediately offered to pay any medical bills. The woman was seen by EMTs and her hand cleaned up but she refused further medical treatment. I spoke to her and informed her of her rights, but she declined to file for DD. County health contacted the dog owner and handled the 10 day quarantine paperwork. I have no other complaints about this dog.

3/20- I received a call from a gentleman from SC who was staying in Fort Edward at his father's house. The father had just passed away. The man had traveled here with his dog and was having issues and looking for assistance. I referred him to some veterinarians in the local area and offered him some advice on making the dog comfortable and helping the dog to feel less stressed. This is information I was able to give due to my participation in the NY State Veterinary Conference.

3/21- I received a call from a woman who stated a dog ran through the screen door of its home on Putnam Ave when she was walking by with her dog. The owner did come out to retrieve the dog. I sent her a complaint form for the details.

3/29- I received the complaint form back. The dog in question has a current license. I sent a letter to the dog owner requesting they remedy the situation so the dog can not break out again.

3/31- I received a call from a woman on Seminary St about a dog running loose near its home and in the neighbors yards. The dog was back home shortly. She said this has happened before. I asked her to fill out a complaint form but she would not. She wanted to remain anonymous. I informed her I have been instructed by local law enforcement not to act on anonymous complaints and she declined to give further information. Sher then stated someone in the village office had contacted the landlord as his tenants have too many dogs. I told her to call me back if she changed her mind but that dog control has no say in landlord/tenant issues over dogs.
