Town of Fort Edward, NY Dog Control DCO Report June 2025

I do not contract with WCPH to handle 10 day QT bite reports. I do keep track of all reported bites in the town.

6/6-I received a call from a DEC officer who responded to a person with a very sick older confused cat that showed up at their home. The officer stated that DEC does not handle domestic animals, however, this cat was very ill and needed assistance. I put him in touch with several cat rescues that may be able to assist and Kitten Angels picked up the cat and got it medical care. Through networking with other rescues and vets during that afternoon the owner of the lost cat was located. This was a group effort to assist an animal who no one in the county has any jurisdiction over.

9/19- The 2025 Animal Crimes Conference was attended via live stream from NYC by myself, 2 law enforcement officers, another DCO, and a representative from a local cat rescue. The watch party took place in the Greenwich town conference room. The conference covered using forensics while investigating animal cruelty cases. I look forward to co hosting this conference presented by the NYS Animal Protection Federation again next year with the Town and Village of Greenwich. The nWCS has informed me with more advanced notice next year more deputies will be able to attend. Thank you to Mayor Amanda Hurley for providing lunch.

This month the dates for the NYS AG and Market ACO/DCO training were announced for the fall session and it was confirmed that I will again attend registered by the Town of Fort Edward and miles for the 2 days of travel to Guilderland and back will again be split among the the other municipalities I work with. With Article 26 c taking full effect in December of this year this conference is very important.

6/2- I was contacted by WCS Deputy DeAngelo. He was seeking assistance with a case involving a woman wishing to get her dog back from her ex husband after having to leave the house due to a domestic violence situation. I spoke with him about the facts of the case. It was very possible the dog was in an abusive situation. I contacted the woman who owned the dog and went over some options with her. Both the deputy and I did not want to exacerbate the domestic violence issues and that fact that she has a protection order complicated things. I spoke to a professional about the legal options available and then reported back to the dog owner and the deputy. It was discovered that family court may be able to order the dog returned to the rightful owner. She said she would contact her lawyer right away to put the request into the court. A letter was sent to the man harboring the dog in Fort Edward on McCrea St informing him I had been made aware he had an unlicensed dog and he needed to remedy the situation before legal action was brought against him. The deputy and I both believed that was the best way to approach him. As of the end of the month neither of us had heard from either party involved and there was a family court date set for the middle of the month according to the woman.

6/4- I attended a court hearing for a DD case that has been ongoing.

6/30- I responded to an email sent by the town attorney with reports on the dog. If the court accepts the reports the case will be closed out next month.

6/26- I received a complaint from a woman about a dog on Wolf St. She claimed the dog 'pursued' her and her dog when they were walking by. This woman called 911 when she got home and this became a WCS investigation. The deputy contacted me after going to the dog's home and said he 'Saw no wrongdoing" and told me "As the DCO I can't see anything for you to do here. "The dog was friendly and in its own yard with an e fence. This woman has complained before in January. There is no report of injury and no complaints from anyone else about this dog. I responded to her complaint via email and reported the sheriff's findings to her as well as suggesting she walk her dog elsewhere. I expect she will continue to complain and so I have sent a copy of the email to the town clerks as well as letting the town attorney know that she may have a problem in the future. Legally there is nothing that I can do at this time.

6/27- I posted the dates of the last few free rabies clinics the county is holding on the local community facebook pages.
