Melissa Davidson Northern Insuring Re: Highway Department Fire **Supervisor Middleton:** I have asked Melissa to come tonight to explain the process we will be going through due to the fire Wednesday night to the Board members so that any questions may be answered. Melissa and everyone at Northern Insuring have been wonderful.

Melissa Davidson: Thursday we were able to get an adjuster out there for the property side of it. He called it a total loss because anytime the building is damaged 50% or more it will be the same to knock it all down as it would be to repair the one side. There was quite a bit of smoke damage to both sides. Today the fire investigator was there and stated that the cause was the truck; I did talk with someone today for the autos and all of the equipment and he will be there Thursday. That portion of the claim usually will move faster than the other portions just due to the fact that they all have stated values on the policy. The property side will take a little bit longer. There are several sub limits of coverage; on your policy there is about \$2.5 million for both coverage of the building and contents. Since you have blanket coverage, each building has a separate sub limit and I believe that building is just a little over \$500,000.00 and about \$60,000.00 in contents but if it does take more than that, since you are on a blanket limit that will come into play. I know we are hoping to get a different rental to keep business operating and you can rent what you need to keep business operating. I represent you; I am your advocate so if you don't agree with what the insurance carrier NYMIR is going to pay then I will be dealing with that side of it. Typically insurance companies are always trying to find coverage for you.

Supervisor Middleton: Monday at 10:00am an Engineer from Morrison Engineering will be coming to look at the building.

CORRESPONDENCE:

Supervisor Middleton: We received a letter from OMNI NAVITAS Solar Energy Development; they are interested in long-term leasing Town land at 45 Leavy Hollow Ln. to build a solar array. I have turned it over to the Town Attorney for review.

Councilman Orsini: I didn't think they could put those on old dump sites. Would it have to go out to bid?

Donald Boyajian, Jr.: I will look into that for our next meeting.

Councilman Mercier: I know that the State maintains that property.

Derek Lyons: If the State owned the land could the Town still grant the lease?

Supervisor Middleton: No but the Town does own it, the State just maintains it.

PUBLIC COMMENT:

Theresa Rose: My garbage has become very heavy from not recycling. If we are paying the Village to use their recycling then what about the people that don't drive, are you still going to pick theirs up?

Councilman Fisher: I would like to point out that no other Towns have curb side recycling pick up.

Supervisor Middleton: No, we will not be picking it up at curbside, we received enough calls and interest from Town residents that would like to use the Village bins and that is why we made the decision.

Elizabeth O'Leary: Do we have to sort it?

Councilman Orsini: No, but they do ask that your cardboard is broken down to make room.

Theresa Rose: Are we still going to be able to vote at the Burgoyne Ave. School?

Supervisor Middleton: If the building is purchased by the County then voting will remain the same.

Theresa Rose: Was the garbage truck in the fire?

Supervisor Middleton: Yes

Theresa Rose: Will it be replaced?

Supervisor Middleton: No, insurance won't cover heavy smoke damage and what they would give us for it is not enough to go out and purchase another one.

Theresa Rose: When are you taking the tree down that was in the accident?

Brian Brockway: That is the County that would be taking that down. That is a County Road.

Theresa Rose: I have a cherry, peach and apple tree that we are cutting down; will you take that if we put it out?

Brian Brockway: We will if it is not more than 6" in diameter or 6" in length.

Theresa Rose: The garbage is piling up again in the yard across the street from me.

Supervisor Middleton: The Code Enforcement Officer is aware of the situation, I have gone there a few times and they will not answer the door and we have also amended our Code to deal with repeat offenders and will be pursuing the issue.

Theresa Rose: I have a problem with garage sale permits, I don't believe anyone should be able to tell me what I can and can't do on my property if they aren't paying my taxes. I am planning on having 2 or 3 garage sales this year and I am not paying or getting a permit.

Supervisor Middleton: Your first 3 day garage sale is free.

Brian Brockway: I would just like to thank all the guys that came down during the fire to help, that is above and beyond and I appreciate it. I also would like to thank the Fire Department for the stop on the fire, they did a great job.

Supervisor Middleton: Thank you as well Brian, you guys all have been doing a great job.
