# 2025 Budget Workshop

Councilman Middleton: Are we adding a line for the Annex building?

**Paul McCarty:** I put a request in for \$5,000.00 for 2025. The bathroom is almost complete and that was done with a grant. The boiler has been sitting for years.

**Peter Ives:** We have \$25,000.00 in the budget for this building. What are you planning to do to that building?

Supervisor Fisher: We need it in case we have to pay someone to get started.

Paul McCarty: Grants are available; we just have to apply for them.

Peter Ives: We can take it out of the general fund if we have to.

**Paul McCarty:** Fort Edward was named almost 270 years ago to the day that the 2025 parade will be held and I feel that should be emphasized as a part of that celebration.

**Supervisor Fisher:** The request for the 2025 Parade contribution from the Town was \$12,000.00. We have to take on some extra expenses next year taking over the Justice Court and Court Clerk which makes that a large ask. We will be getting revenue from the Solar Projects once they are up and running which will help offset those expenses.

#### **Board Contribution: \$5,000.00**

Brian Brockway: The solar money was ear marked for highway equipment.

**Supervisor Fisher:** That was before we had the additional expenses from taking over the Court. We will have revenue from CS Energy, Boralex, Champlain Hudson Power Express and are currently receiving \$69,200.00/yr. from the solar project on our landfill.

Brian Brockway: I will need to get on a build schedule a couple years in advance.

**Paul McCarty:** Union Cemetery is requesting an increase; the cemetery is 23 acres and if they go belly up the Town will have to take it over. We are asking to be increased from \$8,500.00-\$9,000.00.

### **Board Contribution:**

- \$9,000.00 Union Cemetery
- \$1,000.00 Riverside Cemetery

**Supervisor Fisher:** Received a request from Building Inspector Matt French for a 3<sup>rd</sup> week of paid vacation.

**Board Agreed** 

**Paul McCarty:** The Museum was decreased at some point from \$10,000.00 to \$8,500.00 and I am requesting that it be increased to \$10,000.00 especially with all of the Fort Edward Celebrations coming up.

Museum - \$10,000.00 Historian - \$2,150.00

Preliminary Budget Public Hearing will be Tuesday, October 15, 2024 at 6:55pm

-No increase in the tax rate -Not exceeding the tax cap
