PUBLIC COMMENT:

Kyle Cozzens: I own Evergreen Bicycle Works and I am a member of Promote Fort Edward and I would like to bring something to your attention that we are working on through Promote Fort Edward. There is a program called Empire State Trail Towns which is through Parks and Trails

New York. An Empire State Trail Town is a community that recognizes the value of the trail and has committed its time and resources to foster a trail culture and make associated improvements to process, policy and physical infrastructure. The Empire State Trail is the bicycle touring route that runs from New York City to Canada and also includes the Erie Canal Trail from Buffalo to Albany. We intend to apply for this and we need to apply with a municipality; we aren't sure whether we want to go with the Village or the Town but most of what is the trail town is in the Village. The Village is where most of the businesses that are in relation to the trail are located but I just wanted it out there that we will be filling out the application.

Supervisor Fisher: We are definitely in support of that.

Kyle Cozzens: I need to speak with Promote Fort Edward and if we do decide to go through the Town we would be trying to get on the agenda for your next meeting. The application doesn't come out until December 15th; it is a pretty in depth application but there are a lot of benefits for these trail towns.

Supervisor Fisher: When you get more information let us know.

Councilman Middleton: I reached out to no avail to the Glens Falls bus authority which is now CDTA to get a bus shelter there like there was in the past.

Kyle Cozzens: There wasn't even signage; I emailed them before they merged with CDTA because there was no indication of a bus stop and there are many people that get off the train and they come and ask us first but we aren't always there every day. Now there is signage but no outdoor shelter. We do keep that area clear of snow also.

Elizabeth O'Leary: Is there a way to have the bus schedule posted on the inside of the bus shelter as well.

Kyle Cozzens: I tried to get some sort of schedule board from them as well. I told Glens Falls Transit that if they got the information to us at the bike shop we would post it outside so we are willing to help out with that.

Supervisor Fisher: We will reach out to them on these issues.
